- Harassment – Messages or pictures that are obscene, lewd, filthy or indecent with the intent to harass, abuse, threaten or annoy. Harassment is a Petty Disorderly Persons Offense in New Jersey, and juveniles may be charged by school personnel, a parent, or the Police.
- The most common harassing online behavior include:
 - Outing – publicizing another's secrets online
 - Exclusion – intentionally ignoring certain children from online groups or online activities

* *Outing and Exclusion do not always rise to the level of statutory Harassment*

Threats Online

- Terroristic Threat - Any threat which constitutes harm to person, persons and/or property.
 - "I'm going to kill you."
 - "I am going to blow your house up."
 - "I'm going to bring a gun to school and shoot anyone in my way."
 - "Watch your back, you could wind up dead."
- Threats online or in person is a crime in New Jersey, and children may be charged by the school, a parent, or the police.
- Threats should always be addressed and never tolerated.





2. Spend time with your child online.

Child's Pledge

1. I will not give out personal information such as my address, telephone number, parents' work address/telephone number, or the name or location of my school without my parents' permission.
2. I will tell my parents right away if I come across any information that makes me feel uncomfortable.
3. I will never chat online with nor meet in person anyone that I do not "personally" know.
4. I will never send a person my picture or anything else without first checking with my parents.
5. I will not respond to any messages that are mean or in any way make me feel uncomfortable. It is not my fault if I get messages like that. If I do, I will tell my parents right away so that they can contact the service provider.
6. I will talk with my parents so that we can set up rules for going online. We will decide upon the time of day that I can be online, the length of time I can be online, and appropriate areas for me to visit. I will not access other areas or break these rules without their permission.
7. I will not give out my password to anyone (even my best friends) other than my parents.
8. I will be a good online citizen and not do anything that hurts other people or is against the law.

Parents' Pledge

1. I will get to know the services and websites that my child uses. If I don't know how to use them, I will ask my child to show me how.
2. I will set reasonable rules and guidelines for computer use by my child, and will discuss these rules and post them near the computer as a reminder. I will monitor their compliance with these rules, especially in dealing with the amount of time that my child spends on the computer.
3. I will not overreact if my child tells me about a problem that he or she is having on the Internet. Instead, we will work together to try to solve the problem and prevent it from happening again.
4. I will help make the Internet a family activity and ask my child to help plan family events using the Internet.
5. I will try to get to know my child's "online friends" just as I try to get to know his or her other friends.
